Privacy Policy

In this Privacy Policy, 'us,' 'we,' or 'our' means Vertex Forex Funds (2784 LLC 2022) and our related bodies corporate. We are committed to respecting your privacy. Our Privacy Policy sets out how we collect, use, store, and disclose your personal information.

By providing personal information to us, you consent to our collection, use, and disclosure of your personal information in accordance with this Privacy Policy and any other arrangements that apply between us. We may change our Privacy Policy from time to time by publishing changes to it on our website. What personal information do we collect?

How do we collect personal information?
